

## Sales Tax Collections Beginning October 2013

Dear Valued Customer:

As we progress with our transition of former Invacare Supply Group (ISG) customers to our Independence Medical (IM) ordering system, we are beginning the process of collecting resale documents for 30 taxing jurisdictions not previously required under ISG. As you may recall, at the beginning of this year, our company acquired ISG, which covered fewer states. Independence Medical collects sales tax in additional jurisdictions. These additional jurisdictions now apply to former ISG accounts.

To avoid paying sales tax for products to be shipped into any of these newly added jurisdictions, we encourage you to provide us with the proper sales tax certificate(s) as soon as possible.

What you need to do:

- Review the attached list to see if you are impacted by this change.
- If we are shipping into any of these jurisdictions on your behalf, please provide us with a copy of resale document(s) for each jurisdiction.
- If you have already supplied us with this documentation then you do not need to respond.
